




We are submitting for your consideration a proposed Budget for Kenedy County for the fiscal year beginning January 1, 2020, and ending December 31, 2020. The Budget, for a county with an estimated population of 412, anticipates total receipts in the General Fund of \$6,352,827 with total expenditures of \$6,308,195. The proposed ad valorem tax of \$0.719904 per 100 assessed valuation of \$707,603,709 will generate just under 80% of the total receipts. The remainder of the receipts will come from other local sources and federal and state payments.






