Applicants for Kenedy County Permits to Construct/Install Telecommunications Antenna/Tower in Kenedy County that are licensed, permitted and/or regulated by the FCC/FAA shall:

9. \*Neither the Applicant, Property Owner, the owner of the proposed Telecommunications Antenna/Tower, or Contractor shall construct or erect a Telecommunications Antenna/Tower within a one (1) mile (5,280 feet) radius (measured from the center of the tower) of 1) an existing Telecommunications Antenna/Tower or 2) the location of a proposed Telecommunications Antenna/Tower which has been properly permitted by the Kenedy County Commissioners' Court.
