AMENDED KENEDY COUNTY NOTICE OF PUBLIC HEARING ON 2023 BUDGET AND 2022 TAX RATE

A PUBLIC HEARING ON THE PROPOSED BUDGET AND TAX RATE will be held on September 8, 2022 at 2 P.M. at the Kenedy County Courthouse District Courtroom in Sarita, Texas 78385.

A budget for the year 2023 has been proposed in the amount of \$7,222,103.46.

This includes an 8% salary increase for elected officials.

A tax rate of \$0.556376 per \$100 valuation has been proposed by the governing body of Kenedy County.

PROPOSED TAX RATE:	\$0.556376 PER \$100
NO-NEW-REVENUE TAX RATE:	\$0.537427 PER \$100
VOTER-APPROVAL TAX RATE:	\$0.556376 PER \$100

The no-new-revenue tax rate is the tax rate for the 2022 tax year that will raise the same amount of property tax revenue for Kenedy County from the same properties in both the 2021 tax year and the 2022 tax year.

The voter-approval rate is the highest tax rate that Kenedy County may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the voter-approval tax rate. This means that Kenedy county is proposing to decrease the tax rate for the 2022 tax year.

The proposed tax rate is not greater than the voter-approval tax rate. As a result, Kenedy County is not required to hold an election at which voters may accept or reject the proposed tax rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Kenedy County Court of Kenedy County at their offices or by attending the public hearing mentioned above.
