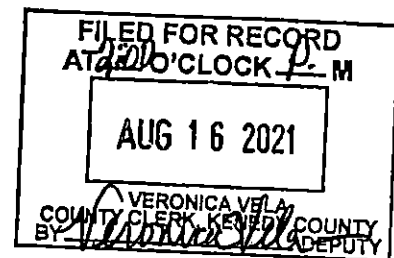


# **LETTER OF TRANSMITTAL**

Citizens of the County


We are submitting for your consideration a proposed Budget for Kenedy County for the fiscal year beginning January 1, 2022, and ending December 31, 2022. The Budget, for a county with an estimated population of 412, anticipates total receipts in the General Fund of \$7,099,196 with total expenditures of \$6,174,651. The proposed ad valorem tax of \$0.670000 per 100 assessed valuation of \$706,723,444 will generate just under 87% of the total receipts. The remainder of the receipts will come from other local sources and federal and state payments.






